### HOW TO PROVIDE YOUR TAX INFORMATION

# **U.S. TAX RETURN FILERS**

- 1. To obtain a 2023 IRS Tax Return Transcript, go to <a href="irs.gov/individuals/get-transcript">irs.gov/individuals/get-transcript</a>. Be sure to request the "IRS Tax Return Transcript" not the "IRS Tax Account Transcript".
  - Get Transcript by Mail Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and *NOT* the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.
  - Get Transcript Online Go to www.irs.gov, click "Get Your Tax Record." Click
     "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the
     "Account Transcript." To use the Get Transcript Online tool, the user must have
    - a) access to a valid email address,
    - b) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and
    - c) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript is displayed online upon successful completion of the IRS's two-step authentication.
  - Automated Telephone Request 1-800-908-9946. The transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
  - Paper Request Form IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

2. Submit a signed copy of your 2023 Federal Tax Return including all schedules.

### **FOREIGN TAX FILERS**

If you filed a 2023 tax return in a country other than the U.S., you must provide a transcript obtained at no cost from or a signed copy and all applicable schedules of the tax information submitted to, the relevant tax authority. This must be translated into English and converted into U.S. dollars. To download the "Foreign Tax Return Conversion Form" go to the Financial Aid Checklist on the FIT portal <a href="majority.fitnyc.edu">myfit.fitnyc.edu</a>.
